









# A report by Peter Campbell (*Donegal Democrat*) on a League game between Cill Chartha and An Clochan Liath on May 20th 2000 In Towney.

A goal a minute from the end of normal time gave Dungloe the two points in a sub-standard Div. I encounter in Towney.

Conditions were a factor, with a cold wind and rain falling on the slippery surface, but to say that the fare on view was poor would be an understatement. Apart from a few well-taken points from Tony Boyle and an expertly hit penalty by birthday boy, Keith Cunningham, the highlights were few and far between. Cill Chartha, without their scorer in chief, Michael Hegarty, could only manage three scores over the hour (none of the forwards scored). Dungloe probably deserved their victory on the fact that they scored double that amount.

Dungloe were without Raymond Sweeney but they were playing a very poor Cill Chartha side which was without the Mc Hughs, David Cannon, Roger Mc Shane and Michael Hegarty. Dungloe had the much better of the opening half and apart from a Brendan Byrne point in the first minute, Cill Chartha failed to raise a flag in the first half-hour. The only other time that Cill Chartha threatened was when Gerard Mc Brearty pulled on a loose ball five minutes from the break to bring a double save from Danny Gallagher. Tony Boyle, with two points in the first ten minutes and points from Myles Sweeney and Charlie Gallagher, left the score at half-time Cill Chartha 0-01, An Clochan Liath 0-04. Cill Chartha were playing with corner-forward Michael Mc Shane in a sweeping role in front of Tony Boyle and he excelled in that role, while Paddy Gallagher did an excellent policing role on Adrian Sweeney. # First half display enough for Gaoth Dobhair

A stunning first half forward's display was enough to give Gaoth Dobhair a big advantage in an away first leg victory against Kilcar in Towney on Sunday evening.

The Gaoth Dobhair forward line was on fire in the first half, with James Gallagher particularly fired up with good support from Stephen Cassidy.

Added to this the winners had a midfield dominance which provided plenty of possession and it was a full thirty minutes before Kilcar came to grips with the situation, and by that stage the horse had bolted with Gaoth Dobhair ahead by 2-9 to 0-4 at the break. The margin of eleven points was helped by a fortuitous goal in the 19th minute. A Stephen Cassidy effort for a point dropped into the net but in essence they were probably worth their half-time lead such was the stranglehold they had.

The second half, however, was a different affair as Cill Chartha re-organised and introduced James McHugh. The fact that Cill Chartha actually won the second half by 1-7 to 0-3 doesn't really tell the story of the complete turnaround in fortunes. Cill Chartha had three or four good goal chances which they faded to take which could easily have resulted in the comeback of the day.

The opening minutes saw James Gallagher ( who had three different markers during the first half ) being fouled and his free could have easily been caught but was deflected over the bar by Keith Cunningham. Tommy Deane equalised from a free at the other end, but by the 6th minute James Gallagher (2) and Sean

Diver had opened up a three point gap. A foul off the ball on Barry Doherty gave Michael Hegarty his only point of the half, as Gaoth Dobhair continued to dominate and points flowed from Stephen Cassidy, Brian Mc Bride and James Gallagher again from a free. Manny Gallagher found an opening in the Cill Chartha defence in the 18th minute to set up a goal chance for Ruairi McCool, but he was wide, almost immediately, though the ball was in the Kilcar net - Sean Diver and Cassidy setting up Manny Gallagher to finish. A minute later disaster struck for the home side, a Stephen Cassidy effort for a point deceiving replacement keeper, Stephen Gallagher to leave Gaoth Dobhair 2-7 to 0-2 ahead. The dominance of Gaoth Dobhair at this stage was underlined by Stephen Cassidy blazing wide after a great catch by James Gallagher, and Gallagher himself shot wide from an easy free. Michael Hegarty robbed a defender at the other end to set up Tommy Deane for a point in the 29th minute and two minutes later Tommy Deane had Kilcar's fourth point from a free. However, both scores were cancelled at the other end, Ruairi McCool pointing and Sean Diver winning and converting a free to leave the half-time score: Kilcar 0-4, Gaoth Dobhair 2-9.

### HALF - TIME

James McHugh, suffering from a back injury, was brought into the Kilcar side at half-time and he had an immediate impact pointing after 15 seconds of the new half. Gaoth Dobhair hit back with James Gallagher winning and pointing a free, and Stephen Cassidy had a great score in the 34th minute to open up a twelve point gap. The first of Kilcar's goal chances came in the 36th minute but corner-back Brendan Boyle made a great block to stop Barry Doherty. James McHugh added another Kilcar point before they got a break in the 10th minute - a Michael Hegarty free was fumbled by Gaoth Dobhair keeper, Sean Sweeney, and Barry Doherty was on hand to flick to the net

Two minutes later another goal chance presented itself to Declan Gallagher but he delayed a little too long and his effort came back off an upright. Brendan Boyle was on hand to bravely defend in a crowded goal-mouth and he won a free out. Michael Hegarty converted a free as Kilcar began to dominate possession. Hegarty, now playing up front found himself through on goal in the 47th minute but his effort from an angle was saved for a '45'. From that kick, he had another goal effort blocked by the keeper.

Again a minute later Brendan Byrne found an opening but his weak effort was saved and from the rebound Barry Doherty toe-poked wide.

Michael Hegarty won and pointed a free in the 50th minute to leave just six points between the sides, and

one felt that the gamble of going for goals too early was working against the home side.

# Gweedore advance to last eight



# TÍR CHONAILL GAELS

## Tír Chonaill Gaels

The year 2000 saw C.L.G Tír Chonaill Gaels become the first British club to own their clubhouse and grounds outright, which was followed by continued achievement on the pitch. The Gaels secured the lease to Ealing Rugby club for 15 years and with the help of a few building contractors with strong Gaels links, the clubhouse was completely revamped.

The AGM, which was held in a half-built clubhouse, found many of the committee members discover that their job descriptions were drastically amended. The roles of President, Francie O' Donnell; Secretary, James Mc Fadden, Towney and Manager Maurice Carr, Largymore, now included the physical transformation of a rugby club into a Tir Chonaill Bar. The bar was opened in June 2000 and 200 members, supporters and players, past and present, celebrated the club's achievement. Two extra committees were set up to deal separately with the running of the bar and the pitches. The grounds include three professionally drained pitches, floodlights and a car park. The club have also drawn up plans for Britain's first under age pitch, now that the U 10's, U 12's U14's and U 16's under Danny Tully, Dunkineely, and Denis O' Leary now dominate the London scene.

Maurice Carr stressed that the club's increased profile off the pitch would be worthless without senior team success. The aim for the Gaels seniors, for 2000, was to reach and win an All Ireland quarter-final. They have battled strongly without success in recent years at the

quarter-final stages against Crossmaglen, Castlehaven and Knockmore and Lavey on two occasions in the early 90's. The Gaels' ever-present supporter, Kilcar's Tony Byrne, will no doubt recall them all. The pressure was on London's Team of the 90's to carry that reputation into the new Millennium.

The Gaels' dominance in London is perhaps best shown by the achievements of Largymore brothers Maurice and Michael Carr. This year's County Championship win over Kingdom-Kerry Gaels was Michael's seventh as a player while it was Maurice's sixth and also his first as player-manager.

The year began with success in the Birmingham 9-a side tournament, which secured an invitation to the Kilmacud 7-a-side tournament in Dublin on the All Ireland weekend in September. This trophy was the first one to be brought back to the Tír Chonaill bar, which had opened two weeks previously. The Kilmacud trip was organised by Stephen O' Byrne, Doonin, who was sidelined all year with a back injury.



With the forwards finding the range, and the Gaels' defence restricting the Kerrymen to just two second-half points, the Donegal exiles were six points clear at the final whistle.




Nemo get the breaks when it matters Nemo Rangers (Cork) Tír Chonaill Gaels

The drought is over! After years of disappointment Donegal claimed the first title of the new Millennium to bring to an end a barren spell that stretches back to 1992.

A large crowd in Gaelic Park, New York, witnessed a strong and determined Donegal team overcome. reigning champions Kerry in the senior "A" decider. In a tough and often uncompromising seventy minutes

of football Donegal triumphed in a contest that did not live up to pre-game expectations.

With so much at stake the final did not reflect the quality which we have come to expect from both teams. Experienced footballers found themselves making elementary mistakes and this contributed to a largely disjointed performance from both teams. I and then going down to Fermanagh in the Championship, before bouncing back in the current league under new management.

Elsewhere at county level the U-21 footballers reached an Ulster final only to be annihilated by eventual All-Ireland champions, Tyrone, while the minors went out at the first hurdle. The U-16s, on the other hand, had a reasonably good year, winning the inaugural Buncrana Cup tournament.

The Donegal senior scene was in a depressed state when the county lost to Fermanagh in the Championship in Ballybofey on June 11th. The match marked the end of Declan Bonner's reign in charge, his high point being an Ulster final defeat in 1998 - thanks to a last minute goal from Joe Brolly.

Bonner, like P. J. McGowan before him, found it difficult to follow the success which the county team enjoyed in the early nineties. With many players coming close to the end of their careers with the '92 success, it was always going to be difficult to mould teams with newcomers coming into panels where there were All-Ireland medals holders.

Now as we approach the ten year mark since that success, only Tony Boyle and Noel Hegarty remain. Most of the rest of that panel have received their 'green jackets' in the Donegal Hall of Fame apart from Martin McHugh, who announced his 'retirement' from club football at the end of 2000 (although he has still not 'officially' retired at county level!). The year ended with the county having a new manager, Derryman Mickey Moran. His appointment caused some difficulty for the 'old brigade' who felt that a Tír Chonaill man should always be in charge. However, Moran has brought a freshness to the side and with five points out of six, the players have responded with great commitment to his urgings. Next May they are due to renew rivalry with Fermanagh, only this time there is an escape net with a new inter-county championship. If they lose they will get a second bite of the cherry.

The new format will have a major impact on club football in every county and The Donegal Co. Board will

need to get their sums right when they sit down to make their plans for the year at the January Co. Board meeting. Hurling again in the county struggled to exis at county level, while at club level Burt continue to win championships, without any real opposition forthcoming.

At club level there was a breath of fresh air with Ardars winning a first championship in nineteen years and Buncrana taking an under-age A title to Inishowen for the first time, when defeating St. Eunan's in the Minor final.

The improvement of Inishowen teams at all levels continues something that owes much to the great work being done on the ground. How long will it be before a team from that part of the county are challenging for the Senior Championship.

The work continues in other areas also with Joe Kelly's U-21s of Cloughaneely putting on a five-star show to win a title for the North West club, while defeated finalists, Termon got some measure of compensation when they came to life in the Intermediate Championship replay to overpower neighbours, St Michael's.

A third adult title went to North-West clubs wher Milford won the Junior Championship, again winning what was nearly a local derby against Glenswilly, who will feel that they must be close also to a Championship winning team.

### **CLUB CHAMPIONSHIP**

At club level in Donegal the winning of the senior championship by Ardara was the story of the year. What chances would you have given them after St. Naul's had defeated them in the first round in Mountcharles on the first Sunday in July. Even in the replay in Pearse Memorial Park they rode their luck before getting to the quarter-final by winning the play-off game. From there the Ardara championship run took off . . . . and by the time they reached terra firma again Johnny D. Earley and his side had the Dr. Maguire Cup back on dry land in Doherty's Bar by the middle of September.

Athletes were not the problem - they have humans in and around the Ardara area who would give Master McGrath a run for his money anytime - the Dohertys, in particular and Diver are prime examples. Indeed the

The Donegal senior scene was in a depressed state when the county lost to Fermanagh in the Championship in Ballybofey on June 11th. The match marked the end of Declan Bonner's reign in charge, his high point being an Ulster final defeat in 1998 - thanks to a last minute goal from Joe Brolly.

Bonner, like P. J. McGowan before him, found it difficult to follow the success which the county team enjoyed in the early nineties. With many players coming close to the end of their careers with the '92 success, it was always going to be difficult to mould teams with newcomers coming into panels where there were All-Ireland medals holders.

Now as we approach the ten year mark since that success, only Tony Boyle and Noel Hegarty remain. Most of the rest of that panel have received their 'green jackets' in the Donegal Hall of Fame apart from Martin McHugh, who announced his 'retirement' from club football at the end of 2000 (although he has still not 'officially' retired at county level!). The year ended with the county having a new manager, Derryman Mickey Moran. His appointment caused some difficulty for the 'old brigade' who felt that a Tír Chonaill man should always be in charge. However, Moran has brought a freshness to the side and with five points out of six, the players have responded with great commitment to his urgings. Next May they are due to renew rivalry with Fermanagh, only this time there is an escape net with a new inter-county championship. If they lose they will get a second bite of the cherry.

The new format will have a major impact on club football in every county and The Donegal Co. Board will

need to get their sums right when they sit down to make their plans for the year at the January Co. Boar meeting. Hurling again in the county struggled to exis at county level, while at club level Burt continue to with championships, without any real opposition forthcoming.

At club level there was a breath of fresh air with Ardar winning a first championship in nineteen years and Buncrana taking an under-age A title to Inishowen for the first time, when defeating St. Eunan in the Minor final.

The improvement of Inishowen teams at all level continues something that owes much to the great wor being done on the ground. How long will it be before team from that part of the county are challenging fo the Senior Championship.

The work continues in other areas also with Joe Kelly' U-21s of Cloughaneely putting on a five-star show to win a title for the North West club, while defeate finalists, Termon got some measure of compensation when they came to life in the Intermediat Championship replay to overpower neighbours, St. Michael's.

A third adult title went to North-West clubs whe Milford won the Junior Championship, again winnin what was nearly a local derby against Glenswilly, who will feel that they must be close also to a Championshi winning team.

#### **CLUB CHAMPIONSHIP**

At club level in Donegal the winning of the senic championship by Ardara was the story of the yea What chances would you have given them after S Naul's had defeated them in the first round i Mountcharles on the first Sunday in July Even in the replay in Pearse Memorial Park they rod their luck before getting to the quarter-final by winnin the play-off game. From there the Ardara championshi run took off . . . . and by the time they reached terr firma again Johnny D. Earley and his side had the D Maguire Cup back on dry land in Doherty's Bar by th middle of September.

Athletes were not the problem - they have humans i and around the Ardara area who would give Maste McGrath a run for his money anytime - the Doherty in particular and Diver are prime examples. Indeed the

Dohertys are just as lean as any greyhound. As well as having the running capabilities, this year also they had a person who fine-tuned them in the form of trainer, Anthony Harkin. That coupled with a 'drink ban' from the beginning of the championship left them in fine fettle when the business end of the championship came around.

History will record that not alone did they win the championship, but they went on to complete the double by winning the League.

#### Failed to deliver

The 2000 championship is all about Ardara - when a new team comes along and wins a championship after a nineteen-year gap, it creates a buzz which has been absent for quite a while.

There had been no real surprises in the opening games with St. Eunan's too strong for an under-strength Aodh Ruadh; Dungloe overcoming neighbours Na Rossa; Four Masters too strong for Glenfin; Naomh Chonaill accounting for Naomh Mhuire; Gaoth Dobhair again coming out on top against Kilcar while MacCumhaill's needed a third game to overcome MacCumhaill's. Indeed the big surprise of the first round was the fact that Ardara were lucky to take their tie with St. Naul's to a third game.

The quarter-finals saw Ardara just about get Four Masters in the closing stages; two games were needed as big crowds flocked to the banks with Gaoth Dobhair, through the finishing of James Gallagher and Stephen Cassidy, accounting for Dungloe, who, not for the first

time, failed to make the breakthrough. An injury to Tony Boyle was a big blow to their chances in the second game.

The loss, through injury, of Paddy Campbell left Naomh Chonaill facing an uphill battle when they encountered hardy annuals, Killybegs, in the quarter-final in Ardara, while St. Eunan's again proved too strong for Naomh Columba without really impressing. Ardara's progress, largely unnoticed, continued in the semi-final with the 'drink ban' and Harkin's training beginning to get them out of the traps quicker and they finished off Gaoth Dobhair in the final minutes. However, it could have been different but for some indifferent shooting by the Magheragallon men.

In the other semi-final Killybegs kept in touch with St. Eunan's for most of the hour, but the Letterkenny side pulled away near the end despite Manus Boyle's best efforts.

Everything was set for the county final with all the focus on the 'new' side, Ardara - even though they were very, very much the underdogs in everybody's book. The word 'underdog' is again appropriate as this young team really took the form of greyhounds as they took the field on county final day, running the opposition ragged. The game had slipped by St. Eunan's before they really knew what hit them. The change from the previous year which saw Charlie Mulgrew with a sideline role, also made a difference - the Letterkenny side suffering from on-field leadership.

Overall, the championship was a success - mainly because of the emergence of a new team - Ardara. They have given hope to the other clubs.

### Fighting an epidemic

In early December Dr. Mick Loftus, former president of the GAA, a doctor in Crosmolina, Co. Mayo and coroner for North Mayo, resigned as president of his local club. A club that he has been involved with for over 60 years. Why? His local club, Crosmolina, has been granted a temporary bar licence for Sunday November 19th, the day that they would host the Galway champions, Corofin in the Connacht club championship final.

I didn't want any big fuss about it" he explained. "It was one of the most regrettable things I ever had to do but I just felt I had to take a stand".

Now 71, he continues to work as a GP in Crossmolina, his native home town, where he practised for the last 42 years. He has been coroner for North Mayo since 1972 and served as president of the GAA between 1985 and 1988.

This uniquely combined professional and public life has helped him project a dissenting view of Ireland's drinking culture, his experiences as a doctor and coroner lending him the authority, his term in office as GAA president giving him the profile. He is but a lone voice, out on the margins and barely audible against the wall-to-wall cacophony of hard-sell advertising and the tidal wave of consumer demand.

Dr. Loftus, insofar as anyone thinks of him, is seen to be belonging to the GAA's Neolithic age: old, old hat and old fashioned. His views on alcohol are about as popular as TB - and belong to that era. He is perceived as a caricature of the old Ireland: the pioneer pin, the GAA man, and the pious advocate of temperance. And over the years it was hard in fairness, to avoid those associations. Two hours spent in his company was enough to shatter those preconceptions. In Séamus Mc Rory's book "Great GAA Personalities", Loftus is described as a "kind, caring doctor" and he is obviously a GP of the old school, immersed in his community, part social worker and social observer, a warm, goodhumoured and palpably a decent His attitude to the alcohol culture is informed by a Ifetime spent dealing with consequences both as a doctor and a coroner.

t was in his early years as coroner for North Mayo that the recurring pattern really struck him. Inquest after inquest into road traffic accidents, suicides and domestic tragedies repeatedly revealed the same underlying cause - the pathologist had more often than not found excessive alcohol levels in the bloodstream. As coroner Loftus was entitled to add an opinion to the findings at any given inquest and as cases mounted he found himself repeating the same message.

" Basically I keep saying about alcohol that if it wasn't promoted the way it is we'd probably have less deaths on the road. I speak out," he adds "because of what I've seen and what I am seeing at the moment". For all his commitment to his beliefs there is no sense of a campaigning crusader about Loftus. Rather he is mild-mannered and low-key. His tone is one of hurt and indignation rather than anger, the demeanour modest and self-effacing. His sincerity on the issue unassailable - it couldn't be any other way, given what he's seen. Road traffic accidents are really heart-rending because it's always someone young. I can see mothers, you know, what they're still going through 20 or 25 years later, you can see the loneliness which is and if you sit them down and talk to them you'll see the tears coming after a while...It has a profound effect, their hearts are absolutely broken".

"They're pushing it on them at a younger and younger age all the time". In December 2000 an edition of Prime Time on RTE featured a report on drinking among young people which backed up Dr. Lotus's assertions. "Irish 16 year-olds top the European league for alcohol consumption," it stated. A new international survey also found that Ireland now has the second highest level of alcohol consumption in the world - up ten places on a previous survey.


One specialist described it as "an epidemic in alcohol consumption" and it is against this backdrop that Dr Loftus condemns the industry's invasion of sport. "It permeates everywhere, not just the GAA but rugby, soccer, racing, you name it, it's everywhere. In soccer you have the Harp Lager FAI cup, in racing you have the Budweiser Derby. If you pass the rugby ground you'd swear it was the Smithwicks/Heineken ground. And of course we have the Guinness hurling championship in the GAA.

When it comes to the organisation he once led as its president, he is nostalgic. "I don't think my life would have been near as happy and enriched if I hadn't the GAA. Out from my family, nothing has given me greater fulfilment - I'd say it has made my life."

On the Guinness sponsorship he says, "I didn't feel let down. I just felt it was wrong. I appreciate the money but I think no matter what money we get it won't compensate for the damage alcohol has done. The GAA reaches into every corner of this country and when young lads playing football and hurling see us adults

accepting it, it's bound to have an influence." But where will the pressure come from? "I think it will come from the parents but the Government will have to lead on this."

Dr. Mick Loftus knows that he is seen as someone with outdated views, a throwback to a more frugal Irish age, marooned in a modern society buoyed by affluence and charged with a new hedonism. But he sees signs of

growing alarm among many people, in the letters, and the calls he regularly receives, "and I know within my heart that there's so many people out there thinking the way I am thinking.

No one shouted stop - another Mayo man, John Healy, once famously wrote - Dr Mick Loftus, at least, will never be accused of that.

#### **Editors Note:**

Spending on alcohol in ireland has increased by almost 70% since 1990. £3.2 billion was spent on alcohol in 1999 compared to £2.2 billion in 1990. In the most recent national health and lifestyle survey, men had 7 drinks "on a typical drinking occasion", whereas women on average 5 drinks.

According to Garda statistics public drunkenness among young people has been steadily increasing since 1994, and shot up in 1999 by more than 20% on the previous year.

Mr Anthony martin, A&E consultant at University College Galway said recently that the soft frink Red Bull, used as a mixer, is aggravating the problem of teenage violence "because it allows them to function while they are drunk and they can keep drinking. Whereas before they would get drunk and fall down, now they're able to stand up and hit you."

Colm O' Rourke, the former meath captain and secondary school teacher, said recently that "young people in their teens were going out drinking late at night and were not able to get up for games the following morning". He added that too much alcohol was drastically affecting many young players' performance on the night before games." In many instances they were not able to play at all, and if they did, their performances were well below par", he said.

County Chariman, John McConnell warned delegates, at the County Convention of 1999/2000, that alcohol abuse by young people was one of the greatest threats to the GAA.





### **ENGAGEMENTS 2000**







On Saturday 1st June 1968 at approximately 9.30a.m. a call came to my front door. I saw an uniformed figure standing there. I had just opened the morning's post, which included a letter from my stepmother. In it she informed me that my father had gone into hospital a few days previously for a course of injections to relieve the arthritis which had plagued him for many years. She told me that he had developed a heavy cold and was coughing frequently. A young doctor had told her that this could affect his heart. Although I was on a week's certified leave from school I resolved to go to see him immediately. I was about to leave when the fateful message arrived. He had died during the early hours of a heart attack. He was three months short of seventysix years of age. It was indeed ironic that a man who had survived five bullet wounds in military engagements, four hunger strikes, the infamous first world war flu and double pneumonia should succumb to an infection incurred while in hospital for medication to enable him to enjoy the remainder of the dry fly fishing season on the local river.

As I drove from my home in Navan to Roscommon I felt very much alone. My wife was housebound with four children, all under four years of age. During that journey, I had time to reflect on the life and career of a man who lived through a great epoch in the history of our nation and who played no small part in shaping its destiny.

My wife, Mary made me promise that I would endeavour to record his life and times, no small task given that I would be working from memory alone. Joe Mac Devitt was born on 1st August 1892, the ninth of twelve children to Charles and Nabla Mac Devitt in Churchtown in the parish of Kilcar in SouthWest Donegal. Charles was a schoolteacher in the small rural village in Muckross. He possessed a very smallholding on the side of the hill, which is Churchtown. A teacher's salary in those days was so meagre that such a family barely lived above the poverty line although the circumstances in the Mac Devitt household would have been considerably better than many of their counterparts in the village. However their conditions were enhanced somewhat by the annual visit of Nabla's brothers particularly John O'Donnell who regularly came on holiday from the United States, a rare occurrence in those times when emigration meant a trip of no return. Not only did John O'Donnell lighten the burden on the family exchequer he also created what could be termed a bursary for the education of any of the family prepared to study for the priesthood. Three were to avail themselves of this facility, Charles, Bernard and Joe.

Muckross School was built literally on the side of a mountain with spectacular views over Donegal Bay. Nevertheless I doubt if the Mac Devitt children who walked barefoot the three miles along a stony path to school had the time or inclination to appreciate the scenery. My father told me that at three years of age he made the journey to school for the most part on his brother Charles' back. This was to ensure that the attendance numbers be maintained to secure my grandfather's continued employment.

As the young Joe grew older and stronger he gave ven to his love of roguery and devilment. The local folklore abounds with accounts of his many exploits on his journeys to and from school. He was often described as the terror of the parish, as it was not known when or where he might strike next. Many a time I have been reduced to tears of laughter when regaled by Joe Mad Devitt recounting the deeds of his early childhood. This penchant for fun and games remained with him for the rest of his life. As a boy he helped his brothers on the farm, saving the hay which was the harvest and planting and gathering vegetables and tending to cattle, few as they were. They also saved their own fuel from the bogs on Coguish Mountain. Joe developed a great love for the outdoors particularly fishing and hunting. He had his own greyhound with which he hunted the wild hare on Coguish Mountain and regularly returned with ample supplies for the family dinners. He would maintain that he had a very happy childhood. Swimming was his great passion and he often chilled me when pointing out the cliffs from which he dived or distances he swam. Towney Bay or Teelin Bay was nothing to him He also developed his skill as an oarsman and sailor at this stage of his life. I am not sure where he got the books, but he told me that as a boy he found inspirational readings in the works of Thomas Davis John Mitchell's Jail Journal and Myles Byrne's history of ninety-eight. These works inculcated in him a strong patriotic and nationalistic fervour that was destined to last.

When the time came for secondary education the future for Joe was already decided. The fact that funding would be made available in the event of his studying for the priesthood meant that he had to enrol in a Diocesan College. There was a rule that only boarding students in a Diocesan College would be admitted to Maynooth College. This condition no longer holds. St. Eunan's College in Letterkenny accepted Joe as student in the early 20th century. An older brother Charles had already passed through St. Eunan's and was currently studying for the priesthood in the Irish College, Salamanca in Spain, courtesy of John O'Donnell. Incidentally one of his classmates in Salamanca was William O'Dwyer of Bohala, Co. Mayo later to become Mayor of New York and brother of the famous congressman and civil rights lawyer Paul O'Dwyer.

De Mac Devitt's experiences in St. Eunan's do not pear to have been very happy. His time there minated in his being accused wrongly of an act of andalism of which he was subsequently cleared. However his refusal to name the culprit did little to dispel the wrath of the authorities and he transferred to Columb's College, Derry. This change made a huge afference. He always spoke lovingly of his time in Derry. He progressed very well in his academic studies and he became an accomplished soccer player. The college played in the North-West league and this put him in contact with many players and officials. He was offered a professional contract with the Scottish Club, Mirren, that did not interest him sufficiently. His interest in drama and elocution was nurtured here and a future Bishop of Raphoe Dr. McFeeley told me how well he played the title role in "The Eloquent Dempsey". Speech and drama became part of his life afterwards. On the completion of his sojourn in Derry he took the matriculation examination, applied for and was admitted Maynooth College.

Again, like Derry, Joe Mac Devitt had fond memories of Maynooth. The only problem was that he discovered after some time that he had no vocation. He often told me that he could not understand in the Maynooth of his tay how anyone could persist without a vocation. The spiritual directors were priests of the Vincentian Order. Their task according to my father appeared to be to encourage all and sundry to leave, preaching of the dire consequences that would befall anyone going through to the bitter end without a "proper" vocation. Nevertheless, he enjoyed the lectures - (he studied Philosophy, Theology and Celtic Studies) - and the sports and the rapport with his fellow students. He found a great outlet for his love of elocution and drama. His teacher was a famous exponent in his day named McHardy Flint. Joe was his star pupil and he would attribute the fame he attained as a public speaker to the great foundation laid by McHardy Flint. He also found time to form a company of the Irish Volunteers and it is recorded in numerous publications of the famous night when drilling in expectation of joining a battalion from Galway on the way to Dublin. The Dean who demanded that they return to their cubicles accosted them. McDevitt's reply became legendary. "How can we sleep when the Capital of our country is in flames". It was Easter Nineteen Sixteen and the devastation that was Dublin then, could be clearly seen on the horizon. It was the first exploit that was to be followed by many in an active role in the War of Independence. His summer holidays around this time were spent on Tory Island where his brother Charles was a curate. Tory Island is a remote fortress nine miles off the North Donegal Coast. He had adequate opportunity for swimming and fishing and a great love for the island and its people lasted a lifetime. He also made contact

with the staff of Cloghaneely Irish College and through them he met Padraig Pearse in whose St. Enda's College, Rathfarnham he was to become a regular teacher. He left Maynooth in the summer of 1916 much to the chagrin of my grandmother. In those days having a "spoiled priest" in the family was regarded as a great affliction. He had nothing to show for his two years in Maynooth but a B.Ph. (Bachelor of Philosophy). He was fortunate to obtain a part time position in St. Enda's that enabled him to complete his degree studies in UCD. Two of his lecturers in the faculty of Celtic Studies were Dúbhglas De h-lde (an Craoibhin Aoibheann) a Gaelic Scholar and poet, founder of Conradh na Gaeilge and Eoin Mac Néill also a Gaelic Scholar and a leader in the Volunteers who attempted to countermand the Rising of 1916. Mac Devitt's experiences in St. Eunan's do not appear to have been very happy. His time there minated in his being accused wrongly of an act of andalism of which he was subsequently cleared. However his refusal to name the culprit did little to dispel the wrath of the authorities and he transferred to Columb's College, Derry. This change made a huge difference. He always spoke lovingly of his time in Derry. He progressed very well in his academic studies and he became an accomplished soccer player. The college played in the North-West league and this put him in contact with many players and officials. He was offered a professional contract with the Scottish Club, Mirren, that did not interest him sufficiently. His interest in drama and elocution was nurtured here and a future Bishop of Raphoe Dr. McFeeley told me how well he played the title role in "The Eloquent Dempsey". speech and drama became part of his life afterwards. on the completion of his sojourn in Derry he took the matriculation examination, applied for and was admitted Maynooth College.

Again, like Derry, Joe Mac Devitt had fond memories of Maynooth. The only problem was that he discovered after some time that he had no vocation. He often told me that he could not understand in the Maynooth of his by how anyone could persist without a vocation. The spiritual directors were priests of the Vincentian Order. Their task according to my father appeared to be to encourage all and sundry to leave, preaching of the dire consequences that would befall anyone going through the bitter end without a "proper" vocation. Nevertheless, he enjoyed the lectures - (he studied Philosophy, Theology and Celtic Studies) - and the sports and the rapport with his fellow students. He found a great outlet for his love of elocution and drama. His teacher was a famous exponent in his day named McHardy Flint. Joe was his star pupil and he would attribute the fame he attained as a public speaker to the great foundation laid by McHardy Flint. He also found time to form a company of the Irish Volunteers and it is recorded in numerous publications of the famous night when drilling in expectation of joining a battalion from Galway on the way to Dublin. The Dean who demanded that they return to their cubicles accosted them. McDevitt's reply became legendary. "How can we sleep when the Capital of our country is in flames". It was Easter Nineteen Sixteen and the devastation that was Dublin then, could be clearly seen on the horizon. t was the first exploit that was to be followed by many in an active role in the War of Independence. was a Donegal woman who will feature later in the account of Joe Mac Devitt's funeral. She became the godmother to one of his daughters, Nuala. Kathleen McLoughlin married Moss Twomey an I.R.A. leader who became the proprietor of a tobacconist and confectionery store - prominently situated in O'Connell Street.) It seems that due to his multifarious activities there was very little time for serious relationships. By 1920 as the battle campaign intensified Joe Mac Devitt went on full-time active service.

He was appointed Director of Organisation in the West with the rank of Commandant. His first assignment was to his native Donegal where the burning of the courthouse took place. Other than the burning of the Courthouse in Donegal Town very little happened. Then he was promptly despatched to the West of Ireland where his desire for action was quickly satisfied. Apart from his organising ability he found himself in charge of a flying column carrying out ambushes. He was now on the run mainly in the Sligo area. Names that readily spring to mind who were contacts or comrades in arms at the time would be Tom Deignan of Riverstown, Jack Brennan of Cloonacool, Jack Leonard of Sligo and Martin Bernard McGowan of Leitrim. I played football for Roscommon C.B.S. against the offspring of those very men. He was a wanted man with a price on his head. Towards the end of 1920 he was captured with Nurse Linda Kearns and Dr. Conlon at a roadblock and after a severe beating was brought to Belfast Jail for charging and sentencing. He was incarcerated in the condemned cell but was reprieved when the British Officer whom he disarmed following the Lough Arrow Ambush and to whom he had shown courtesy on that occasion refused to testify and identify him. (A tape came into my possession a few years ago in which Joe Mac Devitt gives a vivid description of Lough Arrow ambush to an American cousin.)

Then followed a long sequence of prisons mainly in Scotland, such as Edinburgh, Peterhead and Inverness at most of which he organised resistance and as a consequence was in solitary confinement. He was regularly before the Governors for a variety of punishments. One day he was summoned to the Governor's Office and he wondered what new ordeal was being dreamed up for him. Imagine his surprise when the official left his desk and shook hands saying, "I am glad to tell you that your country and ours have signed a treaty."

His welcome home to his native Kilcar is the stuff that legends are made of. At one stage coming down the Trough Brae, able-bodied men removed the pony from the trap and pulled him up and down the village while bonfires blazed on every hill from Slieve League to Croaghmhucross. This joy was to be short-lived as

divisions began to appear when the terms of the Treaty were published.

The main aspects of the Treaty which did not meet with the approval of a substantial minority both in the Dail and the Army (the IRA as the volunteers came to be called after 1919) were the Oath of Allegiance to the British Monarch, Dominion status, partition and the retention of strategic ports by the Royal Navy. The tensions and bitterness were exacerbated by the seizure of the Four Courts by a group of the Army led by Rory O'Connor.

The new Irish Executive Council was under strong pressure from the British Government to deal with the new situation. Eventually Collins gave the order to attack the Four Courts and a bitter and destructive Civil War broke out. Joe Mac Devitt was one of those who opposed the treaty. He maintained that as a member of the IRA he had taken an oath to uphold the Republic and like many others he saw the treaty as a betrayal. I do not propose to dwell on the merits or demerits of the pro or anti treaty positions. Suffice it to say that Mac Devitt felt that it was a clear-cut decision for him. Within the Republican movement of the time or rather separate to it was a secret oath bound Organisation called the IRB - the Irish Republican Brotherhood that Joe Mac Devitt had joined while in Dublin. This was a continuation of the Fenian movement of the 1860's whose rising in 1867 was aborted mainly through the activities of informers. Collins was the leader of the IRB in Ireland and used his position and contacts to identify the latter-day spies and deal with them ruthlessly. My father attested quite vehemently that a secret campaign was undertaken emanating from the leadership of the IRB to have the treaty endorsed by the officers of the IRA. This despite the fact that until his dying day he yielded to no one in his unstinted admiration for Michael Collins. As I have said the following years were bitter and bloody. Mac Devitt was active in South Mayo North Galway area. Michael Kilroy and Tom Maguire, Tom Powell and Mick Martin were the leaders of the Antitreaty forces in the region and he formed a lasting friendship with them. (When my father passed away in 1968, Michael Kilroy was already dead. Dr. Tom Powell and Mick Martin, two former brigades O.C.S. were at the funeral and General Tom Maguire gave an eloquent oration at the graveside.)

He was eventually captured and he avoided execution, he was told, by a mutinous action by some Free State Officers who determined that it would not take place. He was imprisoned in Tintown Camp No. 3 where he completed the hunger strike together with 35 others, among them. Brian O'Higgins, Mick Hilliard and Jim Ryan. When the final order came from De Valera to

timp arms to the "Soldiers of Freedom, Legion of the Fearguard" the prisoners were released. Joe Mac Devitt tells of the ironic situation of arriving in Kilcar th no job, no army commission. In contrast to a few ears previously there was no one to meet him. The following years must have been very difficult. Nevertheless he was far from idle.

He was instrumental in founding the Kilcar G.A.A. Club at a time when soccer was the game played by the young boys of the parish.

t is recorded in "C.L.G. Chill Chartha 1924 -1984" published in 1984 that there were three main reasons for the change-over from soccer to Gaelic in Kilcar.

- Because of Black and Tans involvement in the parish the men became much more nationalistic and adopted the game of Gaelic football in preference to soccer.
- This trend was also very powerful in a the colleges and the boys attending there brought these 'ideals' home to spread among their own kinfolk.
- Because of one Joe McDevitt. He, more than anyone else was instrumental in setting up the G.A.A. in Kilcar.

The following reports also appear in the book, which record his involvement with the club.

1922 politics had determined that these young lads would never play soccer again. Columba Carr and Joe McDevitt, The Murray's and John Gara got the organisational ball rolling in 1922 and over in Towney they were using a field that the soccer team had been using. They bought another piece of land adjoining it from Biddy Jim for £5.00 in order to level the field off.

The official establishment of the club came in late 1923 and afterwards Kilcar began to arrange challenge games with Glen and Ardara. There are no minutes available from those first meetings but some of the main participants were Paddy Tim O'Gara, Hugh Gillespie, Leo Murray, Joe McDevitt, Francis Carr, Pat McShane, Columba Carr, etc.

Joe McDevitt took over the running and training of the team, using the expertise that he had gained in St. Columb's, Derry, and in Dublin. Indeed it wasn't always a smooth road for poor Joe. For instance he found it impossible to persuade some of the players to wear togs so on one particular day in Glen he was so exasperated with the team's narrow-mindedness that he went to the dance afterwards in a pair of short trousers, just to prove a point. Needless to say he didn't get many dances. A dance in these times usually followed a game.

In these first games for the club, Joe McDevitt did a lot of the refereeing.

But now and again Joe ended up in the middle of clubs squabbling, for instance he refereed a game between Donegal and Ballyshannon on December 15th, 1924. The Donegal reporter had the following to say: "There was a palpable foul by two of the Ballyshannon players immediately before the score but the referee apparently didn't observe fouls committed by the visitors. He left many of the spectators present under the impression that he didn't understand the G.A.A. rules ...Mr. Joseph McDevitt, Kilcar, did not give satisfaction as a referee." This prompted the Ballyshannon correspondent to reply in the paper, Friday Dec 26th, 1924: "An unfair criticism . . . " "Only an identness opponent would dream of supposing that the referee, Mr. Joe McDevitt, was partial to any particular team."

"Furthermore, criticism like that does nothing in the furtherance of Irish games. When a team is beaten they should accept their defeat in a sporting manner." Because the 1924 League finished so late the latter stages were to be played in 1925.

A report in the *Democrat* of May 8th, 1925 read as follows: "South and SouthWest League matches have all been played, and the results are as follows . . . ". Kilcar finished third in the League having played eight games, won 3, drew 1, and lost 4. Five teams in all competed in the league. They were Kilcar, Ardara, Ballyshannon, Donegal and Mountcharles."

The top two teams in the South and South-Western League were to play off and the winners were then to meet the Northern champions, Dunfanaghy, in the Championship final. Ballyshannon and Ardara finished first and second in the league but Kilcar protested. "Kilcar protested that Ballyshannon and Ardara be automatically disqualified owing to their not playing at the correct venue", (Democrat, July 21st, 1925). Both teams were supposed to have played their game in Kilcar in the deciding game to see who was to play Dunfanaghy, but both teams agreed to play in Mountcharles. The Kilcar protest was successful and they were to play Dunfanaghy in the county final in Letterkenny on July 26th, 1925. This prompted a reporter from Ballyshannon, pen-name "Assaroe", to publish an attack both belittling and scotching the Kilcar club and its delegates to the Donegal County Executive. The following are extracts from the reply by Joe McDevitt in the following week's Democrat (July 17th, 1925)

"It can hardly be doubted that I am the 'gentleman from Kilcar" to whom Assaroe refers. I do not wish to enter into a newspaper controversy with anyone, much less with one who until recently I believe was an ardent

supporter of the G.A.A. But "Assaroe's" latest contribution to your journal forces me to vindicate myself. First of all as I was openly and bitterly attacked and next my comrades of the Tirconnel County Board G.A.A. Assaroe states that I "bribed" and shrewdly he puts "bribed" in inverted commas, delegates to vote for Kilcar as a venue for the final for the South and South West League. Poor Assaroe! I don't know if he is a Tirconnel man or not but I do know that he is as ignorant of the psychology and sense of honour of the men of Tirconaill as he is of the rules and regulations of the G.A.A. "

Joe McDevitt then went on to explain how at a meeting of the County Board, Kilcar was chosen by a clear majority to be the venue for the final between Ardara and Ballyshannon. Ballyshannon and Ardara had also been proposed as venues but the majority of delegates voted to play the neutral venue. He explains how Ballyshannon and Ardara teams ignored the decision of the executive and took Mountcharles as an alternative venue despite his warning to lodge protest. He goes on: "I proposed that the two teams be suspended, not because I wanted Kilcar to get the league medals. (for we are not accepting them), but because I did not want to see irregularity and anarchy taking the place of regularity and order ..."

"There are no pawn shops in Kilcar of course, or no "cheap medals" exhibited for sale. If there were we would not attach so much importance to them as some people apparently do. We never looked for trophies. We turned up for fixtures more often with inferior teams than with our real team and were prepared to win or lose. The medals for the South and South-West League we will not accept. We do not want any trophies that we did not win on the field. We were the third team in the league surely but if we could chose to wait until Kilcar men - teachers and students - were available I have no hesitation in saying that the probability is we would have as good a chance of heading the league as Ballyshannon or Ardara."

Joe McDevitt lodged the protest, as it was his duty as referee of that league final in Mountcharles on 28th June 1925.

Kilcar travelled to Letterkenny to play Dunfanaghy but they failed to turn up, so Kilcar played a Letterkenny selection instead who were fairly strong at the time. Kilcar went to the game on Paddy Tim O'Gara's (Bradley's) lorry and played the game in a field just outside the town. Joe McDevitt was referee. He noticed that after a while there seemed to be a lot of players on the field and on counting discovered that Letterkenny had fifteen (only 13-a-side at the time). Kilcar won anyway.

At a meeting of the South and South-Western League, Joe McDevitt was a vice-president and James Murray and Dan Byrne delegate.

Failure to travel for games and to get byes were condemned and Joe McDevitt said, "Rather than disappoint Ballyshannon, Kilcar travelled that day although five of their principal players were missing. Teams that have no intention of travelling should not have come into the league."

Mr. Woods, the Ballyshannon delegate, stated that it had cost £12.00 for car hire to Kilcar. Again at the meeting Joe McDevitt answered the criticisms of the Donegal correspondent who had criticised his refereeing between Donegal and Ballyshannon.

He stated: "In the present league he refereed all the matches apart from two as well as most of the friendlies in and around Kilcar and visiting teams coming to Kilcar asked him to referee their matches. Regarding his knowledge of the Gaelic games he was one of the first men in Donegal affiliated to the G.A.A. in St. Columba's College, Derry. Subsequently he studied football in Croke Park.

As president of St. Enda's College (Dublin) he played and refereed matches as he also did in the West of Ireland. So he thought he knew the rules of Gaelic better than the Donegal correspondent. He felt that the proper place for complaints was at the County Board and not through the press. He hoped that all matches would be played in the same sporting manner as Kilcar vs Ballyshannon in Ballyshannon and Ballyshannon vs Kilcar in Kilcar." A vote of thanks was then passed on to Joe Mc Devitt.

Also, during his early involvement with the Kilcar GAA Club, he organised ceilithe for Conradh na Gaeilge. He formed a Drama group that won high acclaim throughout the county. He was in great demand as a public speaker in places like Drumboe (where 4 Republicans were summarily executed as a reprisal) and throughout the country. He could not allow his situation of unemployment to continue. He had no job or prospect of one. The defeated republicans or "irregulars" as they were called were regarded as pariahs by the establishment. Joe McDevitt applied to join the Hudson Bay Company in Canada, which specialised in hunting and trapping animals and fish for commercial purposes. While he was waiting for confirmation of his passage and employment he heard of a vacancy in Omagh, Co. Tyrone for a part-time agent with the Pearl Assurance Company. He decided to apply for the position.

This volte-face on his part could be ascribed to the fact

that he had met a schoolteacher two years his junior also from Kilcar, Annie Brown from Ballymoon, but teaching on Inish Meáin off the Gweedore Coastline. They became engaged and a decision was taken to marry when she felt the hardship and privations of a remote island too difficult to bear. They married and set to house in Omagh where he had obtained the position with the Pearl Assurance Company. He must have done well because within a short time he was appointed ordinary Branch Inspector with the same firm. He went to live in Limerick. As inspector he had "the run of the country" from Limerick to Sligo. My elder sister Eithne and I were born in Limerick. Ruairi who died in infancy and Sile were born in Fermoy.

He was not long in Limerick but continued to participate in extra-curricular activities. He produced The sign of the Cross" to great public and critical acclaim. He was still a member of the I.R.A., which organisation supported De Valera in 1932 with the slogan "Put him in to get them out". Them in question were the numbers of republican prisoners still in jail. For the first and last time in his life Joe Mac Devitt spoke all over Limerick for Fianna Fáil. (De Valera founded Fianna Fáil in 1927 when a motion by him as President of Sinn Fein, permitting members to enter Dail Eireann thereby taking the oath of allegiance to the British monarch was defeated. De Valera lead his blowers from the Ard Fheis and formed Fianna Fáil whose members duly entered Dáil Eireann and in 1932 became the governing party.)

His active association with the I.R.A. faded after this when he became disillusioned with lack of organisation and discipline viz. the Stephen Hayes affair, and the various splinter groups being formed such as Saor Eire, and the Republican Congress. Peadar O'Donnell with whom he disagreed on many issues remained a life-long friend. He failed to interest Joe in Saor Eire.

He was promoted again to the position of District Manager for North Cork and was domiciled in Fermoy. His political activities were curtailed apart from the regular orations. He rented a large house in town on the banks of the Blackwater.

Card playing became a regular pastime, and 110 being the most played game, punctuated by argument and laughter.

Two events from that time stand out in my memory. We travelled to Crosshaven in Cork Harbour to witness the fireworks and general celebrations when as a result of the implementation of the new constitution of 1937, in 1938 the ports were handed back by the British. In the first Sunday in September 1939 we heard the historic statement from Chamberlain that Britain and France had declared war on Germany.

The following year Joe Mac Devitt was transferred as District Manager of the Irish Assurance Company to their offices in South Mall, Cork City. (The Pearl and Prudential Insurance companies were amalgamated within Ireland and became the Irish Assurance Company and later Irish Life.)

He was to have a very happy two years in Cork. He had many friends from the old I.R.A. days such as Tom Barry the Commander of the third West Cork Brigade and Aodh O Tuama and Liam Deasy. He rented a house in Ballintemple in the parish of Blackrock where he developed a great love of hurling which he instilled in me. The house was in Barrington's Avenue, a stone's throw from the Athletic grounds - now Pairc Ui Chaoimh - where all the big games were played. The card games continued. We went to school locally in the O.L.A. convent at Ardfoyle where later on Eithne entered from Letterkenny and Sheila from Roscommon. I was booked into the North Monastery C.B.S. for the year following my departure from Cork.

In 1941 my mother finally succumbed to the regular illness that had beset her over the years. One day we were sent for at school and told that my mother had a stroke. When we arrived, an ambulance was parked outside the house and I remember distinctly climbing onto the vehicle to say goodbye. She died later that evening. Joe Mac Devitt made a decision that for our upbringing we would be better off among our relations in Donegal. Therefore Christmas 1941 found us in Ballymoon, Kilcar and enrolled in Coguish National A vacancy as District Manager arose in Letterkenny and he made a successful application for the post. Wishing to keep the family together he booked us into O'Donnell's Hotel in Letterkenny on a purely pro tem basis. This was a small commercial hostelry famous as the place where Wolfe Tone was identified following his arrest in Lough Swilly. The hotel is no longer standing. (Wolfe Tone was a founder of the United Irishmen, an organisation famous for the rising of 1798 where there was intense fighting particularly in Wexford, Antrim and Mayo. He was arrested when captured on a French ship that was intercepted off Lough Swilly.)

Eventually Joe found a house to rent in Rathmullen, a seaside village 15 miles from his office in Letterkenny. Like many others who did not need a car for emergency purposes he had got rid of his Morris Oxford in Cork shortly after the outbreak of the war. Now he had to cycle 15 miles to and from work and very often had to cycle on various calls throughout the day. He enrolled us in the local primary school, which was to be my fourth - there were five in all. One of my teachers was Annie Keane (nee Browne) a cousin from Carrick whom I remember well as being very kind to us. We got to know the Kennedy's who were to become

our next door neighbours in Letterkenny. Christy, a Garda, was an old friend of my fathers from the footballing days in the 1920's. He was stationed in Ardara then where he married Nan Brennan. She has celebrated her 100th birthday just at the turn of the millennium together with Mrs. McMenamin a native of Rathmullen whose family were also great friends. Lough Swilly was known as the Lake of Shadows and my father got the opportunity of indulging his favourite pastime of angling. He used to fish off the pier for glass on a small but very tasty fish. There was always an abundant supply of them.

In 1943 he married my 1st cousin, the niece of his first wife, Nora Carr, Cougish We knew her well and regarded her as part of the family. It was a very quiet wedding. All I remember is that we were given a day off school. The whole atmosphere at home was transformed. Nora was a very good cook and the fact that she was well known to us made it very easy for us to adapt to the new situation. Being of the same flesh and blood meant that she took a personal interest in our welfare and she relieved Joe of much of the maternal responsibilities. Four children were born of this marriage, Nuala, Delma, Kevin (deceased) and Crona.

He continued to speak on special occasions. I remember him speaking at Drumboe at the annual commemoration and for Sean Mac Cumhaill an independent Republican candidate in 1944 in the famous old Market Square in Letterkenny. (Sean Mac Cumhaill was also an active republican and had been recently released from prison in the North of Ireland and was elected Secretary of the County Board of the G.A.A.)

He renewed his interest in G.A.A. administration and became Chairman of St. Eunan's Club in Letterkenny. It was now that he became passionately involved in angling and found many exciting outlets for his favourite past-time.

Apart from the River Swilly flowing through the town there were many lakes and rivers in the surrounding area providing ample opportunity for this disciple of Isaac Walton; Lough na Cibbon and Garton often provided abundant catches. All these places of entertainment were reached on his trusty bike. He also had access to Glen Veagh where he had a standing invitation to this very private fishery. Lough Fem provided the occasional salmon in the springtime. As stated earlier he eschewed active politics although he was always available for a lecture or an oration. He remained solidly republican although as outlined earlier he had severed all connections with the I.R.A., especially when the Russell and McCaughey element took over.

In 1946, a number of council houses became available on the upper end of the town and we were fortunate to be allocated one. The official name of the area was Ard O'Donnell but the locals hearing all the blasting, necessary even before foundations could be considered christened it the Burma Road. To this day it is still know as the Burma.

Around this time politics beckoned. Sean Mac Bride, an active I.R.A. man until 1938 and the son of renowned parents, Major John Mac Bride executed in 1916 and Maud Gonne, formed a radical political party Clann na Poblachta. During the war years many I.R.A. activists were executed such as Maurice O'Neill, Charlie Kerins, Tony D'Arcy and George Plant. The prominent lawyer, Sean Mac Bride, defended most of these. A substantial minority was outraged especially when it was found necessary to bring over an English hangman to carry out the executions. When Mac Bride announced in 1946 that he was to found a Republican Party to work within the Irish Constitution through solely peaceful means Joe Mac Devitt was one of the first to rally to his side. Meetings were held throughout the country. At this time, 1946, at a County Convention, held in Ballybofey, he was elected Chairman of the County Board of the G.A.A., Sean Mac Cumhaill was elected secretary and Sean Cassidy treasurer. He held this position for two years (1946,1947). Although the Donegal senior team was not particularly successful in those years the position was very prestigious and he had the opportunity of travelling with the Donegal team to places as far away as Belfast and Newcastle, Co. Down. It was at this time that he had a falling out with the St. Eunan's Club and our next door neighbour Christy Kennedy. In 1946 St. Eunan's and Gaoth Dobhair had qualified for the county final. There was an emergency situation throughout the country owing to a disastrous summer. The crops were left unharvested and volunteer groups from the towns and cities were recruited to assist the farmers in their time of need. Major events and sporting fixtures were postponed including the All Ireland finals. The County Secretary Sean Mac Cumhaill called to my father. In those days telephone communication was difficult but they took a unilateral decision to postpone the county final which was to be held on the following Sunday.

The St. Eunan's officials were very annoyed as they felt that my father should have consulted them as he was living in the town. His answer was that it would have been grossly unfair to meet St. Eunan's when it was impossible to contact Gaoth Dobhair. In fact almost half of the St. Eunan's team was made up of clerical students mostly in Dalgan Park and these would not be available for the re-fixture. At a subsequent meeting of the St. Eunan's Club a resolution was passed condemning the action of the Chairman and Secretary

of the County Board. This was passed and Joe Mac Devitt left the meeting together with some others never to return. The Eunan's officials, Christy Kennedy and Joe Callaghan brought their protest to the County Board meeting but it was rejected out of hand.

In 1947 three By-elections were held in the country, Dublin South West, Tipperary North, and Waterford. Clann na Pobachta to everyone's amazement won two of the contests, including Sean Mac Bride in Dublin. There was a great surge of interest and De Valera the astute politician that he was, called a general election. In hindsight the Clann was not ready or organised. They fell into the trap of nominating enough candidates to form a government.

There was little doubt but they wanted Joe Mac Devitt to run in Donegal. He was selected for the West Constituency together with Aodh O' Dubhgain (Hughie Doogan), the grandfather and uncle of the famous singing group Clannad. Sean Mac Cumhaill was selected for the East. (The Chairman and Secretary of the Donegal County Board of the GAA were standing for election to political office). Neither was elected, although Joe came within a hundred votes of unseating Cormac Breslin a sitting T.D. for many years and a subsequent Ceann Comhairle of the Dáil. As it transpired Clann na Poblachta won only 10 seats, but for the first time since 1932 Fianna Fáil lost power. A coalition Government was formed which included Clann na Poblachta. This move angered many of the republicans that supported the party. The bitter memories of the civil war were only a quarter of a century away and the thought of joining forces with the kes of Mulcahy; Mac Eoin and others was anathema to many who immediately resigned. Joe Mac Devitt on the other hand, an indefatigable republican, supported the move. He never allowed bitterness to affect his outlook or approach. He cultivated a friendship with his erstwhile enemies, a fact that enhanced his esteem and social standing.

When the T.D. for East Donegal, Neil Blaney died in 1948 an immediate by-election was called. There were two coalition candidates, the local G.P., J.P. McGinley for Fine Gael and Jim O'Donnell for the Clann. Neil Blaney Junior was the Fianna Fáil candidate. Mac Devitt supported and canvassed for O'Donnell. A public meeting in support of the coalition candidates was called for the Market Square, at which the Taoiseach of the day J.A. Costelloe, Dick Mulcahy, James Dillon Indep.) William Morton (Labour) and Joe Block Clanna na Talmhan) and Seán McBride all spoke. It was agreed unanimously before the meeting that Joe Mac Devitt would preside. His introduction was a tour de force in oratory. The atmosphere was electric and when he called on Dick Mulcahy to speak, his dramatic

and eloquent skills came into play . "There are many here to-night who might think it strange that I share a platform with Dick Mulcahy. Thanks be to almighty God I have lived to see the day." It was pure theatre to see the two old opponents embrace one another on the platform. (It was a scene that will remain on my "inward eye" for the rest of my life.)

Was my father disappointed at not being elected? I feel myself that he shouldn't have been surprised, but there was disillusionment. My stepmother told us that she prayed long and hard that he wouldn't be elected. Peadar O'Donnell, his great friend told him in my hearing that it would be extremely dangerous for him as the Dáil was as he described it 'a drinking den'. The emotional experience of meeting old comrade friends and former enemies could be a grave temptation for one so gregarious. Indeed a saying of his when declining invitations to functions fraught with danger would be 'et ne nos inducas in temptationem''.

A vacancy occurred the following year in West Donegal and despite pressure from Sean McBride that I witnessed myself, in the Central Hotel, Letterkenny, he declined to allow his name go forward.

In 1948 with the ending of petrol rationing he purchased a new car and as his term of office with Donegal County Board was up, he had more time to pursue his hobby of angling. Distance now was no longer a problem and apart from occasional forays into the mountains seeking unexplored lakes, his Mecca was the Kilmacrenan, Cresslough and Dunfanaghy area and of course the magical Lough Veagh. As outlined earlier he had ready access to the estate and very often after a day's fishing we would retire to the castle kitchen for a venison supper with the state staff. It was fishing de luxe in the incredibly spectacular surroundings.

Serious games of poker were played on Saturday nights in our living-room. A regular player was Peadar O'Donnell and I was allowed to stay up until the tea break when I would delight in the discourse monopolised by Peadar and Joe. If a recording had been made it would prove invaluable. These games lasted very often until daybreak.

He still maintained an interest in politics through the local Cumann and the national executive of Clann na Poblachta. He took part in the campaign during the bye-election in West Donegal. I remember travelling with him to Dungloe with Liam O'Doherty where in spite of severe laryngitis he delivered a fiery oration with Dr. Noel Browne then Minister for Health. We had a great night afterwards when Paddy the Cope Gallagher, the founder of the co-operative movement joined us in Donegal and others.

He never lost the opportunity for practical joking although the boot could be on the other foot at times. He purchased a standard 8 car in 1948. It had a Union Jack painted on its bonnet. Joe had the emblem painted over. Some locals had the outer paint removed during the night causing the Union Jack to reappear. Eventually he had the sign removed altogether. There was much amusement in the town over this incident. On another occasion he received a letter from the Lady-in-Waiting to Princess Elizabeth "thanking him for conveying his loyal felicitations on the occasion of her engagement to Prince Philip Mountbatten". His reaction leaves little to the imagination. He found out eleven years later that a St. Eunan's College priest and a friend, Fr. Hugo Bonar had sent the wishes in Joe's name.

He also played a reasonable game of chess and I remember organised games with the Gallagher brothers, both higher Civil Servants, one who became an Ambassador, and Jack Dawson, one of the insurance agents in the house. Dinner parties were organised for students in St. Eunan's College who came from "in through", Kilcar, Carrick and Glencolmcille. These alternated with parties for girls from the local convent. In fact, I can rarely remember our house without visitors or overnight stayers.

In late Spring 1950 Joe told us that he had had a tempting offer. There was a large district in trouble in the West of Ireland comprising all of County Roscommon, East Mayo and part of East Galway as far as Athlone. The Manager was being demoted - reduced was the technical term then and a vacancy would occur. Due to incompetence a large part of the area was untapped and he explained that salary and commission wise with a pension in mind it would mean a lot to a man who would have family responsibility for many years. My stepmother was unenthusiastic but would not stand in his way. Sile and I raised no objections although we were enjoying Letterkenny and doing well in our respective schools. Therefore the momentous decision was taken to leave Donegal and Joe Mac Devitt took up his new position on the third of July 1950, with Headquarters in Roscommon town.

He moved initially and lodged in the town and drove home at weekends. We joined him in November in a house he rented a mile outside the town without water and electricity. Joe adapted very quickly to the new surroundings. We settled in our respective schools, as we were adaptable to change by now. My father had campaigned for Jack McQuillan the Clann na Poblachta T.D. for Roscommon in the local elections of 1950 while still in lodgings. McQuillan was the winner of two All Irelands in 1943 and 1944 with his native County in their only national championship victories. The two men became and remained close friends. In 1951 Dr.

Noel Browne fell foul of the Irish Hierarchy when he insisted on proceeding with his Mother and Child Scheme in the Dáil. In those days the Catholic Church authorities and the Irish Medical Association were establishment bodies that you only challenged at your peril. Browne was forced to resign from the Clann and relieved of the Ministry of Health. My father sympathised strongly with Noel Browne. Jack McQuillan resigned and became an independent T.D. Mac Devitt attended a meeting of the local Cumann where he stated that he would not be returning. He did not wait for the vote, which went strongly in favour of McQuillan. He wrote to both Mac Bride and Browne. Only one thought fit to acknowledge the letter and that was Noel Browne.

Joe Mac Devitt was not a great collector of historical memorabilia and many of the letters he received seem to have disappeared. However, I read the letter in which Noel Browne stated that he appreciated the fact that there were conscientious men in the country concerned about the inadequacies of our health services. My father to my knowledge never spoke from a political platform again. He was available still for lectures and commemorative oration. He spoke at the unveiling of the Heaney memorial in Glencolmcille and the Dermot O'Dwyer plaque in North Frederick Street, Dublin. O'Dwyer was a student of his in St. Enda's who was shot in Frederick Street during the War of Independence.

He was also active in the pre-truce old I.R.A. association and made many representations for veterans not in receipt of a pension. He also organised appropriate ceremonial at the funerals of these former activists. Angling was pursued with renewed vigour and the local river, the Hind, a small tributary of the Shannon yielded many fine catches. Co. Mayo was a happy hunting ground for him. The Yellow River a tributary of the upper Moy, was a magnet for after-work hours in that county. I remember drinking tea with him in a cottage high in the Ox Mountains as the witching hour of night approached. In his latter years he cultivated a skill in fly fishing, a pursuit largely foreign to one used to the fast flowing rivers of Donegal. For a man with a relatively low threshold of tolerance in many other respects he was consummately patient when it came to angling. After retiring in 1957 he continued to take an interest in drama, angling increasingly in gardening. He became president of the Drama Festival Committee and my last meeting with him was in March 1968, in Roscommon town, when in formal outfit he was about to welcome the Director of the Arts Council and others to the opening function.

When I arrived in Roscommon in 1968 I was charged with the responsibility of making all arrangements for the funeral. Nora expressed the wish that he be buried locally in Roscommon. Then followed a series of hectic organising. Major General Frank Simons whom my father held hostage during the civil war was a tower of strength. Tom Maguire the veteran Republican agreed to give the oration. The C.Y.M.S. requested permission to have a guard of honour at the graveside and the surviving local members of the War of Independence were to march from the Church behind the coffin to e cemetery. A bugler from a Western Command of the National Army would sound the last post. He got a send-off worthy of and evocative of his many and varied interests. As we reached the graveyard one mile from town, the rear of the cortege had not yet left Athlone Road. Maguire's address was eloquent and evocative. Dan O'Rourke the former President of the G.A.A. and former T.D. for Roscommon, recited a decade of the Rosary as gaeilge following which the crowd went their separate ways.


One footnote to all this deserves recording. You will remember that Joe Mac Devitt in 1920 was incarcerated Belfast Jail in the condemned cell. During that time one of his visitors was Mrs. Pearse, mother of the executed leader of 1916. She presented him with a gift a small chess set. He often spoke about the same gift during his lifetime wondering what became of it. When the funeral ceremony ended this elderly lady approached me to sympathise. I knew directly who she was when she told me her name was Kathleen Logan. This was the same Kathleen McHugh, one of my father's grifriends during the Troubles. I invited her to the bouse for refreshments. She replied that she was coming not for tea but that she had something for me. an emotional moment she presented me with the thess set that she had kept safe all those 48 years. He and given it to her for safekeeping and she was reluctant part with it.

She knew that I would treasure it. I intend to present it to the museum in Scoil Eanna in Rathfarnham where Joe Mac Devitt from 1918 to 1920 had a brief but distinguished time nurturing the minds of youths that were entrusted to his care.
